This Criminal Original Petition has been filed to quash the charge sheet in STC No.699 of 2022 on the file of the learned District Munsif cum Judicial Magistrate, Sivagiri.

2. Earlier, When the case came for hearing earlier, the learned Government Advocate(Crl.Side) submitted that the investigation in this case is completed and final report filed before the learned District Munsif cum Judicial Magistrate, Sivagiri and the same has been taken cognizance in STC No.699 of 2022. Therefore the learned Counsel for the Petitioner was directed either to not press the petition or file fresh petition. Instead the learned Counsel for the Petitioner sought to file amendment petition, thereby he has filed a petition for amendment in Crl.M.P(MD) No.11766 of 2022 and the same was allowed. Registry was directed to carry out necessary amendment and after amendment the case was posted today.
