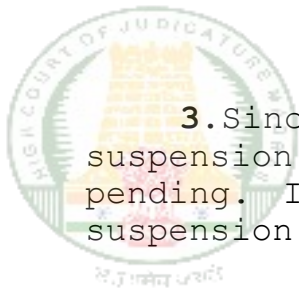
Prayer in CRL A(MD).572/2022 :
