2. Heard the learned counsel appearing for the petitioners and the learned Government Advocate (Crl. Side) appearing for the respondent, Police.

3. Considering the submission made by both sides, the condition imposed on the petitioners in paragraph No.4 in Crl.M.P No. 2687 of 2022, dated 25.08.2022 by the Principal District and Sessions Judge, Ramanathapuram to deposit non-refundable amount each a sum of Rs.25,000/- (Rupees Twenty Five Thousand only) is modified to the

effect that “the petitioners shall deposit non-refundable amount each a sum of Rs.10,000/- (Rupees Ten Thousand only) to the Government of Tamil Nadu - Chief Minister's Public Relief Fund in the order passed in CrI.M.P(MD).No.2437 of 2022, dated 12.08.2022 against them, within a period of 15 days from the date of receipt of a copy of this order”.
