Three Lakh Ninety Thousand Six Hundred and Twenty only) to the respondent Nos.3,4, 5 & 6 under the Workmen's Compensation Act. Aggrieved over the same, the petitioner has preferred this writ petition.

3. When the matter was taken up for hearing, the learned Counsel appearing for the petitioner submitted that the entire amount of Rs.3,90,620/- (Rupees Three Lakh Ninety Thousand Six Hundred and Twenty only) was paid to the respondent Nos.3, 4, 5 & 6. Therefore, nothing survives for adjudication.

4. Hence the Writ Petition is closed. No costs.
