2.The learned Additional Public Prosecutor, on instructions submitted that based on the complaint given by the petitioner, man missing FIR came to be registered on 31.01.2022 in Crime No.53 of 2022. The learned Additional Public Prosecutor further submitted that the second respondent is taking all steps to ascertain the whereabouts of the husband of the petitioner.
