PRAYER :-

For Anticipatory Bail in Crime No.148 of 2022 on the file of the Respondent Police.

ORDER : The Court made the following order :-

The petitioner/A2, who arrest at the hands of the respondent police for the offences punishable under Sections 379 IPC r/w 21(4) of Mines and Minerals (Development and Regulation) Act, 1957 in Crime No.148 of 2022, on the file of the respondent police, seeks anticipatory bail.

2.The prosecution case is that the petitioner and other accused have illegally transported 4 ½ units of savudu sand. Hence, the complaint.

3.On the side of the petitioner, it is stated that the petitioner is innocent and prayed the petitioner to be released on bail.

4.On the side of the prosecution, it is stated that the petitioner is having one previous case, which is similar in nature and the petition to be dismissed.



5. Considering the seriousness and gravity of the offence alleged and on considering the fact that the petitioner is having one previous for similar offence, this Court is not inclined to grant anticipatory bail to the petitioner at this point of time.

6. Accordingly, this Criminal Original Petition is dismissed.
