PRAYER :-

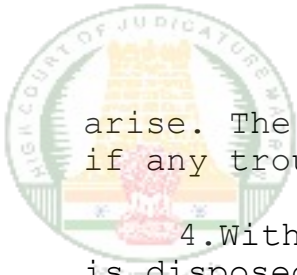
For Anticipatory Bail in Crime No.Not known of 2022 on the file

ORDER : The Court made the following order :-

The petitioner is facing charges under Sections 417, 406 and
376 IPC and Section 67(A) of the Information Technology Act.

2.The learned Government Advocate (Crl.side) for the respondent
would submit that on the basis of the complaint given by the
complainant, enquiry was undertaken in CSR.No.715 of 2022 and so far
no case has been registered against the petitioner and only the
petition enquiry is pending.

3.Since no case has been registered against the petitioner so
far, the question of granting anticipatory bail to him may not



arise. The petitioner can workout his remedy in accordance with law, if any trouble arises during the course of investigation.

4. With the aforesaid liberty, this Criminal Original Petition is disposed of.
