Prayer in CMP(MD)No.9315/2016 : -

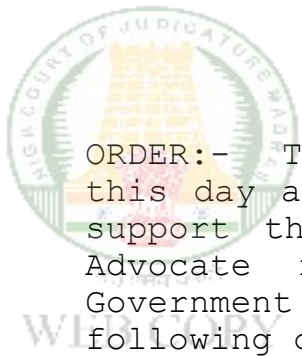
