Mr.Veera Kathiravan, learned Additional Advocate General assisted by Mr.S.Saji Bino, learned Special Government Pleader appearing for the respondents submits that the Inspector General of Prison, vide Proceedings dated 03.01.2022, selected the petitioner for the post of Grade II-Jail Warden and therefore, nothing survives

for adjudication in this writ petition.

3. The learned counsel appearing for the petitioner also admitted the same and submits that the petitioner received a copy of the proceedings dated 03.01.2022.

4. In view of the above, the writ petition is closed as no further order is required in this writ petition. No costs. Consequently, connected miscellaneous petition is closed.

5. This Court places its appreciation to the learned Additional Advocate General for having taken steps for the petitioner to get appointment as Grade II - Jail Warden.
