2.The grievance of the petitioner is that he has made a representation dated 25.04.2022 to the respondents 1 and 2, seeking to release the funds required for payment of compensation of his property in S.Nos.336/6A, Aralvoimozhi Village, Thovalai Taluk, Kanyakumari District, which was acquired by the National Highways Authority, for NH47B bypass road in Kanyakumari District, as per the arbitration award, dated 28.02.2019. But the respondents have not considered the same. Hence, the present writ petition is filed.
