This petition has been filed to modify the condition as far as production of two sureties each for a likesum to the satisfaction of the learned Magistrate concerned in Crl.O.P.(MD)No.15027 of 2022, dated 23.08.2022.



2. Heard the learned counsel on either side.

3. Considering the facts and circumstances of the case, the condition imposed in Crl.O.P.(MD)No.15027 of 2022, dated 23.08.2022 is modified to the effect that the petitioners shall execute a bond for a sum of Rs.10,000/- (Rupees Ten thousand only) with two common sureties, each for a like sum to the satisfaction of the learned Judicial Magistrate Court, Thirumangalam, Madurai.

4. Accordingly, the Criminal Miscellaneous Petition is allowed. The time for surrender and execution of sureties is extended by two weeks from the date of receipt of a copy of this order.
