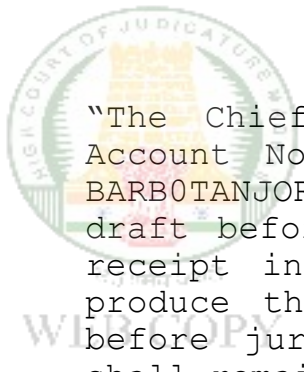

2.Heard the learned counsel appearing for the petitioner and the learned Government Advocate (Crl. Side) appearing for the respondent, Police.

3.Considering the submission made by both sides, the condition No. 1 imposed vide order dated, dated 22.08.2022 made in Cr.M.P.No.3899 of 2022, by the Principal Sessions Judge, Thanjavur is modified to the effect that "the petitioner is directed to pay a sum of Rs.25,000/- (Rupees Twenty Five Thousand only), which is non refundable to the credit of Education Department, by means of Demand Draft to be drawn in any one of the Nationalized Banks in favour of

The other conditions if any shall remain unaltered.

4. This Criminal Original Petition is ordered accordingly.
