This writ petition is filed seeking for a Writ of Mandamus directing the respondents 1 and 2 to release the funds required for payment of compensation for the petitioner's S.Nos.213/16, 216/1, 217/9

and 217/11B at Aralvoimozhi Village, Thovalai Taluk, Kanyakumari District, as awarded by the fourth respondent in the Arbitration Award, dated 28.02.2019 together with all benefits and interest, as per Section 80 of the Act 30/13 by passing orders on the representation, dated 20.05.2022.

2.The grievance of the petitioner is that he has made a representation dated 20.05.2022 to the respondents 1 and 2, seeking to release the funds required for payment of compensation of his property in S.Nos.213/16, 216/1, 217/9 and 217/11B at Aralvoimozhi Village, Thovalai Taluk, Kanyakumari District, which was acquired by the National Highways Authority, for NH47B bypass road in Kanyakumari District, as per the arbitration award, dated 28.02.2019. But the respondents have not considered the same. Hence, the present writ petition is filed.
