This Court, has also directed the Registration Authority to register the document presented by the writ petitioner therein.

3. A perusal of the order passed by the learned Single Judge, in W.P(MD) No. 1032 of 2015, dated 01.06.2015, clearly indicates that the same impugned Memo has been quashed and a direction has been issued to the Registration Authority to register the document.

4. In view of the above said observation, this Writ Petition stands allowed as prayed for. No costs. Consequently, connected Miscellaneous Petition is closed.
