The respondents are directed to complete the enquiry proposed in the impugned show cause notice within a period of 30 days from the date of receipt of a copy of this order. The first date of hearing is fixed on 07.03.2022. The petitioner is directed to appear before the first respondent on 07.03.2022 at 02.30 p.m. Thus, the Writ Petition is dismissed. No costs. Consequently, connected Miscellaneous Petition is closed.
