Prayer in CRL OP(MD). 15286/ 2022 :

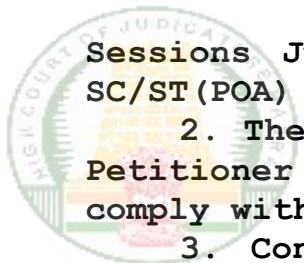
