Writ Petition is filed under Article 226 of the Constitution of India, praying this Court S-12.To issue a Writ of Mandamus to directing the respondents to settle interest at the rate of 18 percentage p.a for the belated payment of petitioners teminal benefits including Gratuity, Terminal leave salary, Provident fund and Commutated value of pension from the date of his retirement to till the date on which the said benefits were settled to him and pass such further or other orders as this Honble Court may deem fit and proper in the circumstances of the case and thus render justice.
