PRAYER: Contempt Petition filed under Section 11 of Contempt of Courts Act, 1971, to punish the respondent for the willful and deliberate disobedience to the orders of this Court made in W.P.(MD) No.4557 of 2021, dated 05.03.2021.

Prayer in WP(MD). 4557/ 2021 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court S-12. To issue a Writ or Order or Direction or in the nature of Writ of Mandamus , directing the respondents to settle interest at the rate of 18 percentage per annum for the belated payment of petitioners terminal benefits including Gratuity , Terminal Leave Salary, Provident Fund and Commuted value of Pension from the date of his retirement to till the date on which the said benefits were settled to him and pass such further or other orders as this Honble Court deems fit and proper in the circumstances of the above case and thus render justice.
