To issue appropriate Writs, Orders or Directions and in particular issue a Writ of Mandamus directing the respondents to settle interest at the rate of 18 per cent per annum for the belated payment of petitioners terminal benefits including Gratuity, Terminal Leave Salary, Provident Fund and Commuted value of pension from the date of his retirement to till the date on which the said benefits were settled to him and pass such further or other orders as this Honble Court may deem fit and proper in the circumstances of the case and thus render justice.
