The prayer in this writ petition is for issuance of a writ of mandamus directing the respondents 1 and 2 to remove the encroachment made by the third respondent in the land comprised in Survey No.286/5A, in Jothi Nagar, Puthusukkampatti Village, Melur Taluk, Madurai, which is classified as a common pathway, based on the petitioner's representations dated 18.10.2017 and 12.06.2018, in accordance with law, within a time stipulated by this Court.

2. Today, when the matter was taken up for hearing, the learned Special Government Pleader appearing for the respondents 1 and 2, on
