No.38 of 2007, dated 04.08.2015 which was confirmed by the learned Principal District and Sessions Judge, Thanjavur, in C.A.48 of 2015 dated 17.03.2016 be and hereby is confirmed and **the sentence is reduced to the period already undergone by the petitioner/accused;** And



3. that the Superintendent Central Prison, Trichy be and hereby is directed to release the accused forthwith, if he is no longer required in connection with any other case or proceedings.
