Prayer in WP(MD). 5066/ 2021 :

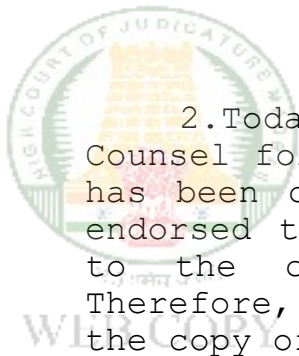
Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the respondents to settle interest at the rate of 18 percentage per annum for the belated payment of petitioner's terminal benefits including Gratuity, Terminal Leave Salary, Provident Fund and Commuted Value of pension from the date of his retirement to till the date on which the said benefits were settled to him and pass such further or other orders as this Hon'ble Court may deem fit and proper in the circumstances of the case and thus render justice.

3.In view of the aforesaid submission, this contempt petition stands closed. However, the respondents Corporation shall furnish a copy of the calculation memo arrived by them to the petitioner and the petitioner is at liberty to challenge the same, if so advised.
