Prayer in WP(MD). 4260/ 2021 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court S-12. o issue a Writ of Mandamus, directing the respondents to settle interest at the rate of 18 perent per annum for the belated payment of petitioners terminal benefits including Gratuity, Terminal Leave Salary, Provident Fund and Commuted value of Pension from the date of his retirement to till the date on which the said benefits were setteled to him.

3.In view of the aforesaid submission, this contempt petition stands closed. However, the respondents Corporation shall furnish a copy of the calculation memo arrived by them to the petitioner and the petitioner is at liberty to challenge the same, if so advised.
