According to the learned Government Advocate appearing for the first respondent, the complainant had appeared before Chief Judicial Magistrate, Madurai and filed a petition under Section 257 of Criminal Procedure Code seeking permission of the Court to withdraw the complaint, based upon which the complaint was permitted to be withdrawn. The first respondent has also recalled the communication
