2.The learned Government Advocate (Crl.side) appearing for the Respondents 1 to 4 submitted that the 5th Respondent/Complainant gave a complaint before the Respondent Police and it was retained as current paper. He further submitted that the 5th Respondent/De-Facto Complainant himself is not co-operated with enquiry.

3.In view of the above submission, the 5th Respondent/Complainant is is directed to co-operate with the pending investigation. The Respondents 3 and 4 are directed not to harass the Petitioner and also to follow the guidelines issued by the Hon'ble Supreme Court of India in the case of ***Lalitha Kumari Vs. Government of Uttar Pradesh*** reported in **2013 (6) CTC 353**.
