Prayer in WP(MD) . 4531/ 2021 :

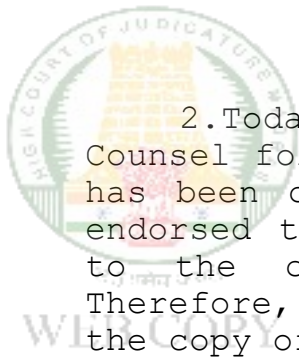
