Writ Petition is filed under Article 226 of the Constitution of India, for issuance of Writ of Mandamus to direct the respondents to settle interest at the rate of 18 percentage p.a for the belated payment of petitioners terminal benefits including Gratuity, Terminal leave salary, Provident fund and Commuted value of pension from the date of his retirement to till the date on which the said benefits were settled to him.
