PRAYER: Contempt Petition filed under Section 11 of Contempt of Courts Act, 1971, to punish the respondent for the willful and deliberate disobedience to the orders of this Court made in W.P.(MD) No.4964 of 2021, dated 09.03.2021.

Prayer in WP(MD). 4964/ 2021 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court S-12. To issue a Writ of Mandamus, directing the respondents to settle interest at the rate of 18 percentage per annum for the belated payment of petitioners terminal benefits including Gratuity, Terminal Leave Salary, and provident Fund from the date of his retirement to till the date on which the said benefits were settled to him and pass such further or other orders as this Honble Court may deem fit and proper in the case and thus render justice.

3.In view of the aforesaid submission, this contempt petition stands closed. However, the respondent Corporation shall furnish a copy of the calculation memo arrived by them to the petitioner and the petitioner is at liberty to challenge the same, if so advised.
