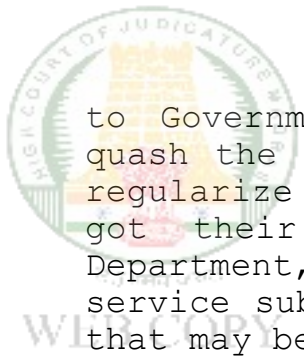

Prayer in WP(MD). 1417/ 2017 :

Writ Petition is filed under Article 226 of the Constitution of India, for the issuance of Writ of Certiorarified Mandamus, to call for the records of the first respondent i.e., the Principal Secretary to Government, Public Works Department, Chennai, relating



to Government Letter No.10204/C2/2016-4 dated 19.09.2016, to quash the same and consequently, to direct the first respondent to regularize the service of the petitioner on par with the 222 persons got their services regularized in G.O.Ms.No.202 Public Works Department, dated 01.08.2012, who have completed ten years of service subsequent to the petitioner, within a specified time frame that may be fixed by the Court.
