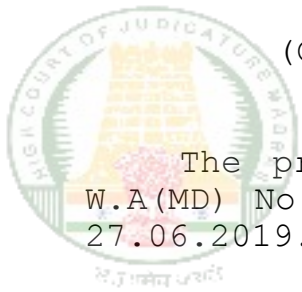
Prayer in CMP(MD) . No.9965 of 2019 :-
