ORDER

On such surrender and on filing of bail application by the Petitioners herein, the learned Special Judge for the Exclusive Trial of SC and ST Cases, Theni, shall consider the bail application and pass appropriate orders as per law.

5.With the above directions, this Petition is allowed.
