Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certiorarified Mandamus, calling for the records relating to the impugned proceedings issued by the 4th respondent District Educational Officer in O.Mu.No. 6681/ Aa1/2018 dated 25.02.2019 QUASH THE SAME and further DIRECT the 3rd and 4th respondents to approve forthwith the appointment of Tmt.B.Antony Mercy Maria Hemi as BT Assistant(Science) in the petitioner school w.e.f., the date of her appointment viz., 02.07.2018, with all attendant benefits including the arrears of salary and allowance.
