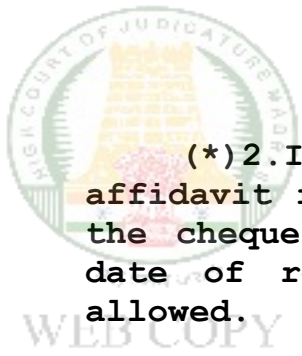
Petition filed praying that in the circumstances stated therein and in the petition filed therewith the High Court may be pleased to extend the time imposed by this Hon'ble Court in Crl MP (MD) No.9854/2022 dated.25.08.2022 in Crl RC No.791/2022 the petitioner shall deposit 25% of the cheque of Rs.3,00,000/- (Rupees Three Lakshs only) to the credit of STC No.732/2016 before the learned Judicial Magistrate No.II (FTC Magistrate Level), Madurai on or before 08.09.2022.

Prayer in CRL RC(MD) .791/2022 :

To call for the records and set aside the judgment of learned VI Additional Sessions Judge, Madurai in Crl.A.No.34 of 2020, Dated. 11.11.2020 and confirming the judgment passed by the learned Judicial Magistrate No.II (FTC Magistrate level) Madurai in STC No.732/2016 Dated. 29.01.2020 under Section 138 NI Act for the simple imprisonment of 6 months and to take compensation of Rs.12,00,000/- to the respondent/respondent/complainant under Sec.357 of Cr.P.C. to be paid within 3 months and in default to undergo simple imprisonment for 2 months.
