3. The learned IV Additional and Sessions Judge, Tirunelveli had offered remarks. As per his remarks he had assumed office only on 04.08.2022. The sessions case was made over to the Court of the learned IV Additional and Sessions Judge, Tirunelveli and re-numbered as S.C.No.314 of 2022. He further submitted that the prosecution has opened prosecution arguments on 31.10.2022

4. The learned Additional Public Prosecutor would submit that the case stands posted to 11.11.2022 for framing of charges.

5. As per the remarks offered by the learned IV Additional and Sessions Judge, Tirunelveli in letter in D.No.964 of 2022 dated 28.10.2022 already prosecution had commenced opening the prosecution case on 31.10.2022. Therefore in the light of the remarks offered by the
