PRAYER: Contempt Petition filed under Section 11 of Contempt of Courts Act, 1971, to punish the respondent for the willful and deliberate disobedience to the orders of this Court made in W.P.(MD) No.5737 of 2021, dated 15.03.2021.

Prayer in WP(MD). 5737 of 2021 :

Writ Petition filed under Article 226 of the Constitution of India, praying this Court for issuance of Writ of Mandamus directing the respondents to pay interest at the rate of 18 percentage per annum, for the period of delay from 01.06.19 to 24.01.21, in paying the amounts paid towards the terminal and pension benefits of the petitioner namely EPF Employees Contribution and Gratuity, Encashment of Earned / Sick Leaves and Commuted Value of Pension, within a time frame as may be fixed by this Honble Court and without affecting his right to claim balance amounts towards those benefits.
