PRAYER: Contempt Petition filed under Section 11 of Contempt of Courts Act, 1971, to punish the respondent for the willful and deliberate disobedience to the orders of this Court made in W.P.(MD) No.3312 of 2021, dated 22.02.2021.

Prayer in WP(MD). 3312 of 2021 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court S-12 To issue a Writ of Mandamus directing the respondents to pay interest at the rate of 18 percentage per annum, for the peroid of delay from 01.07.2019 to 24.01.2021, in paying amounts paid towards the terminal and pension benefits of the petitioner namely EPF Employees Contribution, Gratuity, Encashment of Earned/Sick Leaves and Commutated Value of Pension, within a time frame as may be fixed by this Honble Court and without affecting his right to claim balance amounts towards those benefits.
