PRAYER: Contempt Petition filed under Section 11 of Contempt of Courts Act, 1971, to punish the respondent for the willful and deliberate disobedience to the orders of this Court made in W.P.(MD) No.3289 of 2021, dated 22.02.2021.

Prayer in WP(MD) . 3289 of 2021 :

Writ Petition is filed under Article 226 of the Constitution of India for issuance of Writ of Mandamus to direct the respondent to pay interest at the rate of 18 percentage per annum, for the period of delay from 01.06.19 to 24.01.21, in paying the amounts paid towards petitioners terminal benefits namely EPF Employees Contribution, Gratuity and Encashment of Earned / Sick Leaves within a time frame as may be fixed by this Honble Court and without affecting my right to claim balance amounts towards those benefits.
