PRAYER: Contempt Petition filed under Section 11 of Contempt of Courts Act, 1971, to punish the respondent for the willful and disobeying and not complying with the orders of this Court made in W.P.(MD)No.5661 of 2021, dated 15.03.2021.

Prayer in WP(MD) . 5661/ 2021 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue appropriate Writs, Orders or Directions and in particular issue a Writ of Mandamus directing the respondents to pay interest at the rate of 18 percentage per annum, for the period of delay from 01/07/2019 to 24/01/2021 , in paying the amounts paid towards the terminal and pension benefits of the petitioner namely EPF Employees Contribution , Gratuity , Encashment of Earned / Sick leaves and Commutated Value of Pension , within a time frame as may be fixed by this Honble Court without affecting his right to claim balance amounts towards those benefits.
