PRAYER IN CRL RC(MD)SR.No.24109 of 2021:

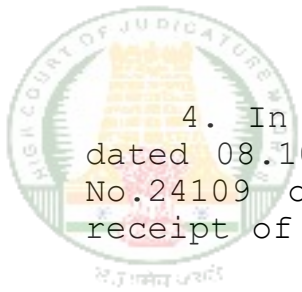
