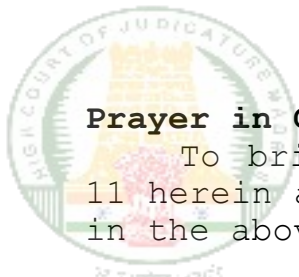
Prayer in CMP(MD) . 6187/ 2018 :
