PRAYER: Contempt Petition filed under Section 11 of Contempt of Courts Act, 1971, to punish the respondent for the willful and deliberate disobedience to the orders of this Court made in W.P.(MD) No.5960 of 2021, dated 17.03.2021.

Prayer in WP(MD). 5960 OF 2021 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus or any other appropriate Writ, Order or Direction particularly in the nature of Writ, directing the respondents to settle Petitioners surrender leave salary for 90 days in respect of the years 2010-2011, 2011-2012, 2012-2013, 2013-2014, 2014-2015, 2015-2016, 2016-2017, and 2017-2018 together with interest at the rate of 18 percentage per annum payable from the date for retirement to till the date of actual payment.
