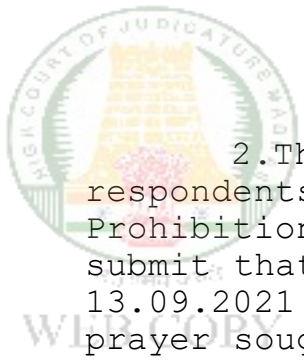
ORDER

The petitioner is the sister of the detenu, namely, Bottle Mani @ Dineshkumar, S/o Jon Kennedy, aged about 28 years. The detenu has been detained by the second respondent by his proceedings in Cr.M.P.No.38/2021 dated 13.09.2021, holding him to be a "Goonda", as contemplated under Section 2(f) of Tamil Nadu Act 14 of 1982. The said order is under challenge in this Habeas Corpus Petition.



2.The learned Additional Public Prosecutor appearing for the respondents by producing a copy of G.O.Rt.No.5835, Home, Prohibition & Excise (XII) Department, dated 29.11.2021, would submit that the impugned detention order in Cr.M.P.No.38/2021 dated 13.09.2021 has been revoked by the Advisory Board. Hence, the prayer sought for herein has become infructuous.

3.Recording the same, this Habeas Corpus Petition is dismissed as having become infructuous.
