To issue appropriate Writs, Orders or Directions and in particular issue a WRIT OF MANDAMUS directing the respondents to pay interest at the rate of 18 percent per annum, for the period of delay from 01.05.19 to 24.01.21, in paying the amounts paid towards the terminal and pension benefits of the petitioner namely EPF Employees Contribution, Gratuity, Encashment of Earned or Sick leaves and Commuted Value of Pension, within a time frame as may be fixed by this Honorable Court and without affecting his right to claim balance amounts towards those benefits.
