PRAYER: Contempt Petition filed under Section 11 of Contempt of Courts Act, 1971, to punish the respondent for the willful and deliberate disobedience to the orders of this Court made in W.P.(MD) No.5757 of 2021, dated 15.03.2021.

Prayer in WP(MD). 5757/ 2021 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court S-12. to issue a Writ of Mandamus directing the respondent to pay interest at the rate of 18 percentage per annum, for the period of delay from 01.06.2019 to 24.01.2021, in paying the amounts paid towards the terminal and pension benefitsof the petitioner namely EPF Employees Contribution, Gratuity and Encashment of Earned/Sick Leaves and Commutated Value of Pension, within a time frame as may be fixed by this Honble court.
