Prayer in WP(MD). 3401/ 2021 :

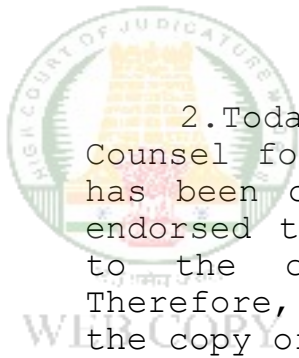
Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Mandamus directing the respondent to pay interest at the rate of 18 percent per annum, for the period of delay from 01.05.19 to 24.01.21, in paying the amounts paid towards my terminal benefits namely EPF Employees Contribution, Gratuity and Encashment of Earned/Sick Leaves within a time frame as may be fixed by this Honble Court and without affecting my right to claim balance amounts towards those benefits and thus render justice.

3.In view of the aforesaid submission, this contempt petition stands closed. However, the respondent Corporation shall furnish a copy of the calculation memo arrived by them to the petitioner and the petitioner is at liberty to challenge the same, if so advised.
