PRAYER: Contempt Petition filed under Section 11 of Contempt of Courts Act, 1971, to punish the respondent for the willful and deliberate disobedience to the orders of this Court made in W.P.(MD) No.5745 of 2021, dated 15.03.2021.

Prayer in WP(MD). 5745 of 2021 :

Writ Petition filed under Article 226 of the Constitution of India, for issuance of WRIT OF MANDAMUS to direct the respondents to pay interest at the rate of 18 percent per annum, for the period of delay from 01.06.2019 to 24.01.21, in paying the amounts paid towards the terminal and pension benefits of the petitioner namely EPF Employees contribution, Gratuity, Encashment of Earned/Sick Leaves and Commutated Value of Pension, within a time frame as may be fixed by this Honourable Court and without affecting his right to claim balance amounts towards those benefits.
