2.The learned Government Advocate (Crl. Side) takes notice for the respondents and would submit that difficulties have been experienced and exposed by the respondent police on 02.10.2022. There are several events have been arranged and they have give protection to the above said events. Therefore, they are not in position to extend the protection to them. The petitioner may arrange the rally to some other day. So far the distribution of prices to the School Students, they have no objection.

3.The respondents give no objection for the price distribution. Let the programme with regard to the price distribution may be taken on that day itself . So far as rally, the petitioner may arrange an alternative date
