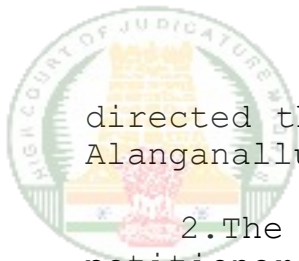

Time to execute sureties also extended for a period of two weeks, from the date of receipt of a copy of this order.
