2. There is no representation on behalf of the Petitioner.

3. The learned Additional Public Prosecutor would submit that the First Information Report was registered by the Srivilliputhur Town Police on 16.10.2022 in Crime No.446 of 2022 for the offences under Sections 406 r/w.34 of IPC.

In view of the same, the Superintendent of Police, Virudhunagar District is directed to nominate a Senior Officer not below the rank of Deputy Superintendent of Police to supervise the investigation.
