Prayer in CRL RC(MD) . 5/ 2020 :

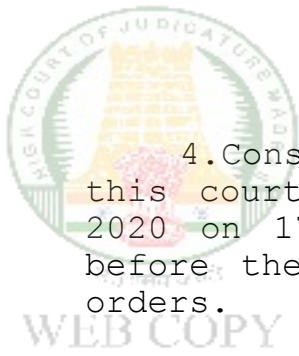
